



Assumption of Risk. I understand that participating in an event organized, co-organized, sponsored, hosted or otherwise supported by Oregon Humane Society (“OHS”), regardless of OHS’ specific role in the event (the “Event”) includes inherent risks to myself and, if applicable, any animal(s) accompanying me, including but not limited to falls, collisions, illness, injuries caused by animals (including bites, scratches, escape or loss of an animal), spectators or other participants, weather conditions (including temperature extremes and humidity), surface conditions, facilities, equipment, activities, transportation, Event operations, and other unforeseen hazards. I also understand that spectators may be present at or around the Event. I voluntarily assume all risks associated with my participation and, if applicable, the participation of my animal(s) in the Event.

Release of Liability. Having read this waiver and knowing these facts, and in consideration of being permitted to participate in the Event, I hereby for myself, my heirs, executors, administrators and assigns waive, release and discharge OHS, any other organizer of the Event, the owner(s) of the premises, governmental entities with jurisdiction over the Event location, Event officials, volunteers, sponsors, suppliers, agents, independent contractors, employees, and their respective officers, directors, representatives, and affiliates (collectively, and together with OHS, the “Event Parties”) from any and all liability for injuries, damages, or losses of any kind that may arise directly or indirectly from my participation and, if applicable, the participation of my animal(s) in the Event, including, to the fullest extent permitted by applicable law, those caused by the negligence of Event Parties. This release does not apply to liability for gross negligence, recklessness, or intentional misconduct, to the extent such liability cannot be released under applicable law.

Indemnity. I agree to indemnify, defend, and hold harmless the Event Parties, to the fullest extent permitted by applicable law, from any claims, damages, losses, liabilities, or expenses (including reasonable attorney's fees) arising out of my participation and, if applicable, the participation of my animal(s) in the Event, including but not limited to claims brought by third parties or other participants.

Permissions. I understand and agree that the Event Parties may subsequently use, for publicity or promotional purposes, photographs, videos or recordings of me or my animal(s), if applicable, or my name or other information, without liability, compensation or

obligation to me. I may decline this permission by notifying OHS in writing prior to the Event.

Representations. If I am bringing an animal(s) to the Event, I certify that my animal(s) is/are in good health and up to date on all vaccinations required by applicable law and Event rules, and I agree to keep my animal(s) under control at all times during the Event and on a leash when required by law or Event rules. I acknowledge that I am solely responsible for the behavior and control of any animal(s) accompanying me and for any injury, damage, or loss caused by such animal(s). I also confirm that I am physically able to participate in the Event and that OHS does not provide medical or veterinary assistance. I agree to abide by all the rules of participation in this Event. I agree to abide by any decision of an Event official or representative of OHS relative to my, or my animal's, ability to participate in this Event safely and further agree that Event officials may obtain or authorize emergency medical, veterinary, rescue, or transportation services for me or my animal(s) if deemed reasonably necessary. I agree to be financially responsible for any costs associated with medical, veterinary, rescue, or transportation services obtain on my or my animal's behalf.

Minors. Entries from minors will only be accepted with a parent or legal guardian's signature and the same conditions apply to all minors participating under the supervision of a registered participant. If I am signing on behalf of a minor, I represent that I am the minor's parent or legal guardian with full legal authority to bind the minor to this waiver, and I agree, on behalf of myself and the minor, to all of the terms of this waiver, including the assumption of risk, release of liability, and indemnity provisions above, to the fullest extent permitted by applicable law.

Severability. If any provision of this waiver is found to be invalid or unenforceable, that provision shall be limited or eliminated to the minimum extent necessary, and the remaining provisions of this waiver shall remain in full force and effect.

Electronic Acceptance. I agree that my electronic signature, electronic acceptance, or checking of any acknowledgment box related to this waiver shall have the same force and effect as an original handwritten signature.
