### 2019 Vendor Packet

#### 1. APPLICATION PROCESS:

- Vendor Fee: \$100
- OHS reviews all applications to ensure that all items and services complement our mission and are not in direct competition with our Sponsors.
- Upon approval, an OHS representative will email you a confirmation notice. If you do not receive this notification within two weeks of submitting your application, please contact the event organizer.

#### 2. INSURANCE:

- Fire, loss, theft, workers compensation (if applicable) and liability insurance in limits of \$1 million and an aggregate of \$2 million must be procured by the Sponsor at its own expense. The Oregon Humane Society must be named as an additional insured. Liability certificates may be obtained as an insurance rider through your current insurance provider.
- Proof of insurance does not need to be submitted with the application, but **we MUST receive proof of insurance by 5/10/19.**

#### 3. CANCELTION POLICY:

- Vendors who cancel on or before 5/5/19 will receive a refund of one half of the total fee.
- Vendors who cancel after 5/5/19 or do not show up for the event will not be entitled to a refund.

#### 4. BOOTH SPACE:

- OHS will determine the location for each Vendor's space. Any locations determined prior to the event day may be changed or altered on the day of the event by event staff.
- **Each Vendor must have a canopy**—canopies should be 10' x 10'. Please also bring your own tables and chairs, unless prior arrangements are made with OHS.
- No water connections or electrical connections are provided at Vendor booths.
- You are not allowed to share your booth with another company or organization, unless approved by OHS staff.

#### 5. BOOTH SETUP:

- Booths are located on NW Flanders St, between NW 13<sup>th</sup> and 14<sup>th</sup> Ave (street is closed to traffic during the event).
- Vendors may set up between 10:00am – 11:45am on Sunday, 5/19/19. Vendors may drive onto NW Flanders St to unload and must be off the street by 11:30am.
- Vendors must pack up immediately following but **not before** the end of the event at 4:00pm.

#### 6. DAY OF EVENT REGULATIONS:

- Non-profit organizations are allowed to hand out information, but may not solicit donations.
- Neither Vendors nor any others may sell pets of any kind on or near the event grounds.
- Items given out must be safe for children and pets. Please ask owners before giving their pet a treat due to possible pet food allergies.

- You may bring your dog with you! Dogs need to be kenneled or kept on a leash at all times. Pick up after your pet. Dogs must be licensed and current on Parvo and Rabies vaccinations. Do not bring female dogs in heat. Dogs must have good temperaments.

**7. PRIZE REQUEST**

- Prizes for the Pug Parade winners are greatly needed. We ask all Vendors to donate one or more items to be included in the winner baskets (there are four total winners). Providing items helps OHS to save on purchasing prizes, and funds can be saved to support the shelter animals.
- Non-profit organizations are exempt from this requirement.
- Please bring the item(s) to the event. An Oregon Humane Society representative will pick up the item from your booth and provide a donation receipt at that time. Be sure to include promotional materials (i.e., business cards, brochures, etc.) with your item.

**8. OTHER VENDOR RESPONSIBILITIES:**

- Sponsors are responsible for:
  - fees associated with any damage a Vendor causes to any Pug Crawl related property.
  - the safety of all money and items.
  - cleaning up their area after the event.
  - transporting all trash, compost and recyclables (i.e., cardboard) to their designated on-site receptacles.
- Per ADA requirements, Vendors will make their services and products available to all people; this may require you to exit your booth area to assist a customer if needed.
- Please understand that if any of the terms described herein are not followed, OHS may refuse your participation in this and future events.
